## Use the Serco Apprenticeship Diploma to upskill your teams

In Serco we want to support our existing workforce in their professional development and build our capability of being able to deliver in-house accredited qualifications. These qualifications can give your employees certificates and diplomas in qualifications and subjects ranging from Business Administration, Customer Service through to Manufacturing and Aeronautical Engineering.

All Serco Apprenticeship Diplomas are delivered, supported and assessed through Serco Skills and are currently funded through the Skills Funding Agency (SFA) and therefore there is no training cost on top of your normal employment costs for supporting your teams in gaining these qualifications.

From April 2017 the way these qualifications will be funded is changing with the introduction of the new Apprenticeship Levy – the qualifications will still be funded by the government and as currently there will be no additional training costs above normal employment costs and the time dedicated to the learning.

The majority of employees within Serco are eligible for gaining a Serco Apprenticeship Diploma. It is a common misconception that it is only open to new employees aged 16-18.

## At a glance:

- The Serco Apprenticeship Diploma is open to Serco employees in England
- There is no age limit it is open to all employees of any age
- There are no restrictions on the employee's length of service
- The course length is one year as a minimum. The course is structured to allow the learner to be assessed during the course of the programme to ensure he/she is meeting the requirements
- Until April 2017, employees must choose a course at a level higher than the highest qualification they may already hold. Please note that new government guidelines from April 2017 may mean that this could change.
